Angels Park: Continued progress being made with sidewalks. Water aeration project is looking promising with an anticipated installation date in the Spring of 2015. A child swing was damaged recently, and the responsible child and parents have been identified.

Approval to purchase new swing (no more than \$100.00) and to send bill to responsible parents: Motion Nichols, 2nd Werkmeister.

Ameri Corps Works on Parks: Offers free of charge labor for park improvements. Looking to keep 10-14 people busy for 6-8 weeks. Need to see if this is plausible soon.

FEMA will help pay up to 75-80% to remove the tree at Meyers Lake and the tree at Bunger Park if approved. Estimated cost for Meyers Lake is \$2500.00. Estimated cost for Bunger Park is \$1200.00.

Motion to approve \$3000.00 for Meyers Lake tree and \$1500.00 for Bunger Park Tree removal: Motion Kettwig, 2nd Adams.
